# Thank you to Donna Neely for 17 years of service to Community Action.

Donna Neely began her service as a board member in 1993. As a volunteer of Crosslines Food Pantry, Mrs. Neely served the WCMCAA Governing Board as a representative of the low income. She was elected as Board Chair in 1995 and served in this capacity for 15 years. In addition to her work in Community Action, Neely has served her community in various other capacities including volunteering her time to organizations such as: Hospital Auxiliary, Eastern Star, Cedar County Cancer Committee, and service to her church.

In January 2010, Mrs. Neely announced that due to personal health concerns, she must resign from the WCMCAA Board of Directors. With her resignation Mrs. Neely stated, "It has been an honor for me to serve on the board ... WCMCAA has done tremendous work for not only the low-income, but for our entire communities. The staff of West Central are tireless and committed and it has been a joy to see their work over the years. Lastly, I want to say that I have valued the leadership, dedication and vision of Amos Jackson, President and Chief Executive Officer. ### American Recovery and Reinvestment Act of 2009 Community Services Block Grant Projects

As a result of American Recovery and Reinvestment Act (ARRA) funding being funneled through the Community Services Block Grant (CSBG) Program in Missouri, West Central Missouri Community Action Agency has developed



several new and exciting projects. On February 25th, Chris Tuckness, WCMCAA Community Services Director, provided the WCMCAA Governing Board with updates regarding strategies, progress made and future plans regarding these projects. The projects are as follows:

#### **Community Empowerment Collaboration (CEC)**

This is a state wide project that all 19 community action agencies are charged with to align local efforts to support the Missourians to End Poverty coalition and to develop a local recovery sustainability plan. Local groups have been formed or WCMCAA has joined with existing groups in all nine counties in the service area to accomplish these goals. (Please see page 7 for a listing of scheduled events.)



#### **Community Improvement**



This project was developed to work with five separate communities. In collaboration with WCMCAA, Drury University, Hammons School of Architectures', city mayors, business owners and residents will work towards revitalizing these communities and developing long term plans for future success. Appleton City, Urich, Hermitage, Montrose and Windsor were selected. The Appleton City Vision Plan has been completed. Students are now working with Montrose and Hermitage. Work will begin with Urich and Windsor semester with a new group of Drury Architecture students.

#### **Community Employment/Education Network**

The goal of this project is to work in collaboration with the new Community Association of Regional Enterprises (CARE) group to market their new Community Development Center in Clinton, Missouri. This facility, which was formally Wetzel Clinic, has been renovated and will sponsor college class in the upper level provided by State Fair Community College (2 year degree) and Central Methodist University (4 year degree) and in the lower level has been furnished to house 22 incubator businesses. Currently, there are 8 incubator businesses located in the Business Development Center.





#### **Back Packs**

The goal of this project is to begin a Back Pack Program so that each child attending public elementary schools and WCMCAA Head Start Centers will receive food to take home on the weekends. School districts and Head Start centers typically serve breakfast and lunch to each child and in some cases this may be the only meals they receive that day. This will provide additional food so that we can be sure they have something to eat on the weekend. WCMCAA has established partnerships with organizations in each of the nine counties served to implement and sustain this project. Anyone wishing to contribute should contact WCMCAA to learn more about the project in their area.

#### RRR Project – Reduce, Reuse and Recycle

This project could reduce our waste and have a significant impact on landfills and the environment. Our goal is to educate our children on recycling, and finding ways to reduce waste and reuse what is available to us. There are also opportunities of "green jobs" that already exist; this endeavor would bring awareness to these jobs. This program will be provided to 30 groups, schools or organizations.



#### Step Up to Leadership

This program is designed to help low-income individuals build self-confidence along with the skills and knowledge to serve on boards and committees in their community. The goal is for them to realize their potential and that they too can have a voice for change in their communities. One Step Up to Leadership Class has graduated in Belton, with two students applying for and receiving mini-grants to implement community projects. Classes are now underway in Clinton and Nevada.



#### **Connecting Seniors**

This project was submitted to develop a plan that will help seniors with issues that every rural community seems to be facing. The top five concerns: transportation for medical or errands, affordable housing/home repair/maintenance, senior supportive services, in-home assistance and social and civic inclusion. WCMCAA is partnering with Care Connection for Aging and Area Agency on Aging to implement this project.

**Renewable Energy** This is a state wide initiative. A feasible business plan will be produced for the 19 Community Action Agencies throughout Missouri to create renewable energy job opportunities in each area of the state.



**Family Development** Several additional Community Action projects are being implemented to help in the development of individuals and families in our communities: Life Skills Classes, Back to School Fairs, Energy Conservation Education and Financial Management.

#### **Prevention Strategies Include:**

- Educate yourself on the indicators of abuse and neglect.
- Report known and suspected abuse / neglect promptly
  - Be proactive within your organization or agency
  - Provide prevention education and share information.
    - Provide parents with education in development, parent and child relationships
- Provide parents with information on community resources
  - Encourage early and regular child and family screening and treatment
    - Enhance child care opportunities,
    - i.e. crisis care, emergency or respite care.
  - Refer parent to Early Head Start and Head Start
- Maintain a network of contact with local social service agencies.
  - Contact your local Children's Division office
  - Remember prevention is everyone's responsibility.

# **Dreams Really Can Come True**with Hard Work and Perseverance!



Stephan and Lucinda Pennington enrolled in the Family Self-Sufficiency Program on 06/01/07. They completed the program successfully in just two years and recently purchased a home of their own. One might ask, "How did they do this?" The answer would be, they accomplished their goals with hard work and determination.

When they enrolled in the FSS Program, they were experiencing struggles like many families. Stephan and Lucinda had health problems and they were deep in

debt with limited income, as Stephan was not employed. However, in just two years they have overcome the barriers that held them back.

As a backdrop to our story, it is important to know that Lucinda grew up in foster homes and she experienced repeated abuse—both physically and sexual. She was a Ward of the State of Missouri and emancipated at a young age. It wasn't like she had planned for this future but she was a victim of circumstance and she felt trapped. Lucinda had trouble in school and was labeled "unable to learn."

As a person not likely to succeed, Lucinda proved the school system wrong. She enrolled in college and worked hard. She passed her classes. Prior to finishing college, she met Stephan and she left school to become a mother. Stephan was a pastor and they are raising four daughters.

As health issues surfaced and Stephan was no longer able to work, Lucinda went to work as a Youth Specialist for the State of Missouri. She worked with troubled youth and wrote curriculum that was adopted by the State of Missouri. Throughout her employment, she has continued to complete her studies. She graduated with a Bachelor's Degree in Biblical Counseling from Calvary Bible College in May of 2009, as well as beginning her Mater's Program in January 2009.

Stephan was approved for Social Security Disability and upon receipt of the Social Security lump sum payment, they paid off medical, vehicle and credit card debt. Not only were they able to clean up their debt but they were approved for the purchase of a home of their own. They used their WCMCAA Family Self-Sufficiency escrow balance of \$3,344.00 as a down payment on their dream home. **Dreams can come true with hard work and perseverance—just ask the Pennington's'.** 

If you thought the might be the end to the story, you would be wrong. In the last few years,

Lucinda has not only lost 213 pounds but she has prepared manuscripts and she is currently working out the "book details" with a publisher on a story about her life. *It just goes to* 

show, that we are only limited by the barriers that we are unwilling to overcome.


